Recent Cases Al Wathba Stables: Waad Nadim Moghlbay and Daiana Chopita

On 9 December 2017, Endurance rider, Daiana Chopita competed in the CE11* 100 on horse JC Cahuel. On 23 December 2017, endurance rider Waad Nadim Bou Moghlbay participated in the CEI2* 120 on the horse JLB Noche. Ms Chopita also competed on another horse, HLP Gadafi. Both riders are from Al Wathba Stables. Samples taken from the three UAE registered horses, namely JC Cahuel, JLB Noche and HLP Gadafi following their respective events, revealed the presence of Trometamol, a Banned Substance listed on the 2017 FEI Equine Prohibited Substances List. Both riders were provisionally suspended on 9 and 10 January 2018 respectively as the Person Responsible. Following an investigation, it was established that the source of the Trometamol found in the horses' samples was a supplement that contained Trometamol as an unlisted and inactive ingredient (alkalizing agent), which Ms Chopita and Ms Bou Moghlbay could not have known about. Morgan Sports Law subsequently submitted a request to the FEI List Group that the classification of Trometamol be revised to a Controlled Medication (rather than a Banned Substance). This request was accepted by the FEI List Group and was later approved by the FEI Bureau, meaning that as of 1 January 2019 Trometamol will be reclassified as a Controlled Medication (subject to acceptance by the National Federations). In light of the reclassification, MSL reached a settlement agreement with the FEI that meant Ms Chopita and Ms Bou Moghlbay would serve a backdated six-month period of ineligibility (instead of a possible 2 years). This agreement was ratified by the FEI Tribunal and incorporated into a Final Decision, meaning that both riders were immediately free to return to competition.



Paige Johnson

In April 2017, Ms Johnson was suspended from competition after being notified that a Banned Substance, Pramoxine, had been detected in a sample collected from her horse, Luke Skywalker 46, in February. Ms Johnson was able to prove the source of the Banned Substance. The horse's groom was under strict instruction to treat cuts or bruises with a particular brand of antibiotic cream, in order to adhere to the FEI equine anti-doping rules. The groom mistakenly selected a very similar looking product from a shop shelf and administered it to the horse. This product contained added pain relief in the form of Pramoxine. The case was initially heard before an Independent Panel of the FEI, who accepted that the mistakenly purchased product had caused the positive test. Importantly, the Panel recognised that Ms Johnson bore no significant fault or negligence, noting that she was conscientious in the care of her horses and had extensive policies and systems in place to prevent doping violations. Banned Substance cases typically carry a two-year suspension period. Taking account of Ms Johnson's low level of fault, the FEI Panel reduced Ms Johnson's suspension to one year. Ms Johnson elected to appeal the FEI's Decision to the CAS. Additionally, Morgan Sports Law applied on Ms Johnson's behalf to the FEI Prohibited List Group advocating for the reclassification of

Pramoxine. MSL was able to provide compelling scientific evidence that Pramoxine should be classified as a Controlled Medication (and not a Banned Substance) because it was commonly used in horses and had therapeutic benefits. The reclassification request for Pramoxine was successful which converted Ms Johnson's violation to the far less serious Controlled Medication violation. Due to the reclassification of Pramoxine. together with the FEI Panel's finding of no significant fault or negligence, Ms Johnson was able to reach a settlement with the FEI. Her suspension was reduced to three (3) months, backdated to the date of sample collection. Accordingly, Ms Johnson was free to resume her riding career with immediate effect from the date of the settlement.

Sofia Abramovich

Morgan Sports Law acted for equestrian rider, Ms Sofia Abramovich, in her successful sport nationality change from Russia to Great Britain. Ms Abramovich was born in Great Britain and has lived in Great Britain for over ten years. As of 7 February 2019, she is able to compete for Great Britain. Ms Abramovich intends to participate in the Sunshine Tour Championship and Longines Global Championship Tour in 2019, as a Great Britain rider. ■
